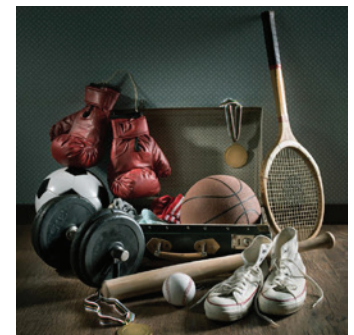

# The 2026 Merit Rewards program incentivizes Chevron Lubrication Marketer Sales Employees for winning Chevron-branded lubricant business.

- **Login at [meritrewardsprogram.com](https://meritrewardsprogram.com)** to access your account and redeem your points.
- **The Merit portal will be used to:**
  - Upload claims
  - View program claim data and Merit point awards
  - Access redemption portal
  - View important program information
  - View Elite Sales Contest leaderboards
- **Merit points will be earned/paid by product tier** (see following table) – on an actual per litre/kilogram sold basis **as documented by claim/invoice data uploaded to the Merit portal.** *Note: Private Label volume does not qualify.*
- **Merit points will be earned on qualifying volume sold** and claimed for up to a maximum of **12 months** from date of the first invoice on a **NEW\*** Account.
- **Lubrication Marketer administrative users will be able to bulk submit invoices** for points processing.
- **Claim invoice(s)/claim data for each sale/transaction** must be loaded to portal **within 60 days** of the invoice date on **NEW\*** account to be considered for Merit points. *Note: Official invoice is required. Order Confirmation, Quote, Shipping Confirmation, Delivery Ticket are not accepted.*
- **Invoice must clearly state Chevron Product information** and volume/weight per product sold.
- **Merit points awarded in 2026 will expire 12 months** after issuance. *Important Note: All points issued prior to 2026 will expire 12/31/2026.*
- **You can redeem your points for a reloadable gift card** in addition to the current catalog of redemption options.
- **Lubrication Marketer Sales Reps can participate in contests** for trips and other prizes based on number of points earned in the Merit program.
- **Customer address\*\* is required** for all invoices/submissions. Invoices/submissions for Will Call/Pick Up orders must contain the customer's Bill-To address.

*\*New is defined as any customer that has NOT purchased Chevron products previously. NOTE: Accounts previously claimed/paid in the Merit Rewards program or customers claimed in previous promotions are not eligible. MSA accounts are not eligible.*

*\*\*Invoices/submissions for any non-deliverable addresses by USPS/ Freight Carriers (Longitude/Latitude, Construction Site or Oil Site) may require additional documentation.*



# Establishing your personal Merit reward account in the Merit reward program:

**1) Invoices submitted by Lubrication Marketer administrators** may require the creation of new member accounts if the designated sales employee on the submitted invoices does not already exist in the Merit program. The new member will receive a welcome email with temporary login information. Upon first login the new member will be required to update their password.

**2) ALL Canada participants in the Merit program** will be asked to provide your agreement to reporting of any income earned to CRA (Canada Revenue Agency) in accordance with tax reporting requirements. This must be done yearly. Once received, your Personal Account in the Reward Redemption Portal will be established and earned points will be loaded to your account.

*Canada Participants previously earning/redeeming points in the Merit program will be required to submit an updated tax reporting agreement form.*

**3) New Merit participants will receive Personal Account** log-in credentials and point redemption instructions for the Reward Redemption Portal via email. (Look for an email from [info@Meritrewardsprogram.com](mailto:info@Meritrewardsprogram.com) in your inbox) Please keep a secure record of the new Merit portal URL and your login credentials.

**4) You can accumulate Merit points** or redeem immediately for great rewards! Points earned in 2026 expire 12 months after issuance.

## **TERMS AND CONDITIONS**

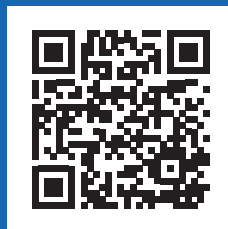
- The program described in this document is only available to Lubrication Marketers (LMs) in the U.S. and Canada who have a current Chevron LM Agreement.
